## QUALIFYING REQUIREMENTS FOR INTERNATIONAL BUYERS

- Be a legally constituted company in your country or region.
- The company must have been legally incorporated for at least 2 years. Priority will be given to those buyers who have been in business the longest.
- The company must demonstrate that it has imported from any market.
- The company must have a catalog of products and/or services and a web page.
- The company's delegate to participate in the matchmaking must be a decision-maker with experience and comprehensive knowledge of the company to attend the scheduled meetings with potential customers.
- The company's delegate must be available to attend the meetings before the Business Matchmaking proposed by the Bogotá Chamber of Commerce to validate the type of company, sector, and product and/or service they are interested in.
- The company's delegate must comply with the conditions for lodging, transportation, and airline tickets stipulated by the Bogota Chamber of Commerce.
- The participating company must assume the costs of food, individual domestic transportation, medical insurance, travel expenses, change in rates, and other expenses for the delegate, which the Bogota Chamber of Commerce does not cover.
- Providing a timely response to the requirements of the Bogotá Chamber of Commerce in terms of periodic follow-up of business, reporting sales, and/or expectations generated during and after the activity.
- The person delegated by the company must comply with the requirements and regulations in force to travel to Colombia. Consultation on compliance with travel requirements must be made directly by the businessperson interested in participating in the activity.

### Notes:

1. The Bogota Chamber of Commerce and AmCham are not responsible for entry into the country or for processing travel documents and/or passports.
2. The Bogotá Chamber of Commerce facilitates connecting entrepreneurs and companies to promote business opportunities, trade, and collaboration. ## ¿HOW TO PARTICIPATE?

1. Log in to the platform and carefully fill out all the required fields. The email address you entered will be the only way to contact you, so please verify it. Registration will be open from June 5th to August 30th.

3. The scheduling team will generate a long list of potential partners, and once you approve them, the business appointment schedule will be structured on the platform. You will not request appointments directly; the team will manage everything.
4. If no Colombian companies are found that match your interests, you will be notified that you have no confirmed business appointments and will not be able to participate in the matchmaking.
5. The deadline for submitting the required documentation for ticket and accommodation arrangements is August 30th.
6. Your business agenda will be fully structured by September 16th.
